

LIMITED WARRANTY

Watkins Manufacturing Corporation ("Watkins") warrants to the original consumer purchaser ("you") the following about your new Endless Pools® Fitness System or SwimCross™ Exercise System by Endless Pools, when purchased from an authorized dealer/service provider ("dealer").

The following applies to all of the warranties listed:

Extent of Warranty

This warranty extends only to the original consumer purchaser of the **Endless Pools Fitness System** or **SwimCross Exercise System** when purchased and originally installed within the country of purchase. This warranty begins on your delivery date of the system, but in no event later than one year from the date of purchase. This warranty terminates upon any transfer of ownership, or if the system is installed or relocated outside the country of purchase by the original consumer purchaser prior to the expiration of the warranty period.

Warranty Performance

To make a claim under this warranty, contact your dealer. You must give Watkins and/or your dealer written notice of any warranty claim, along with a copy of your original purchase receipt indicating the date of the purchase, within thirty (30) days of the time you discover the claim. Watkins reserves the right to inspect the malfunction or defect on location.

Watkins or its Authorized Service Agent will repair any defects covered by this warranty. Except as described herein, you will not be charged for parts, labor or the freight costs for parts necessary to repair the system for defects covered by this warranty. In some cases, the servicing dealer may charge you a reasonable repairperson travel/service charge that is not covered by this warranty. Please contact the dealer for information regarding any such charges.

Limitations

10 Year No Leak Shell Warranty

Watkins warrants against water loss due to defects in the Endless Pools Fitness System or SwimCross Exercise System shell for ten years.

7 Year Shell Surface Warranty

Watkins warrants the acrylic surface material of the **Endless Pools Fitness System** or **SwimCross Exercise System** to be free from defects in materials and workmanship for seven years. Additionally, the acrylic surface material is structurally warranted not to leak for a period of seven years. The acrylic surface material is non-permeable and will not absorb odors, bacteria or pollutants.

5 Year No Leak Plumbing Warranty

Watkins warrants the **Endless Pools Fitness System** or **SwimCross Exercise System** against leaks caused by defects in manufacturing and workmanship for five years. This warranty specifically covers leaks from the wall fittings, jet fittings, internal plumbing, internal glue joints, drains, hoses, and all bonded parts.

5 Year Component Warranty

Watkins warrants the electrical components, pumps, jets, air valves, levers, bezels and other **Endless Pools Fitness System** or **SwimCross Exercise System** components against defects in materials and workmanship for five years. Some parts, most of which can be changed out without the use of tools, such as filter cartridges, filter lid, spa pillows and cover locks, are not included in this warranty, but are warranted to be free from defects in materials and workmanship at the time of delivery. System covers and other accessories are specifically excluded from this warranty, although they may be covered by other warranties. Please check with your **Endless Pools Fitness System** or **SwimCross Exercise System** dealer for details.

5 Year Heater Warranty

Watkins unconditionally warrants the heater to be free from defects in materials and workmanship for five years. This warranty defines unconditional, with the exclusion of commercial or industrial use, and improper installation, as warranty coverage provided that the component has failed to operate properly within the system.

5 Year Cabinet Warranty

Watkins warrants the **Endless Pools Fitness System** or **SwimCross Exercise System** cabinet material to be free from defects in materials and workmanship for five years. This warranty specifically covers the cabinet's structural integrity (exclusive of surface stain), including the material and assembly.

2 Year Light Assembly Warranty

Watkins warrants the LED light assemblies, which consists of all lights within the system, including the underwater and exterior, to be free from defects in materials and workmanship for two years.

2 Year Water Sanitation Warranty

Watkins warrants the electrical components, ozone tubing, check valve, injector, UVC light bulb, corona discharge cell and exterior housing of the corona discharge ozone purification system against defects in material and workmanship for two years.

1 Year Sound System Warranty

Watkins warrants the factory-installed sound system, which includes the stereo, speakers and amplifier to be free from defects in material and workmanship for one year.

LIMITED WARRANTY

Watkins Manufacturing Corporation (“Watkins”) warrants to the original consumer purchaser (“you”) the following about your Endless Pools® Fitness System Swim Machine, when purchased from an authorized dealer/service provider (“dealer”).

2 Year Endless Pools® Fitness System Swim Machine Warranty

Watkins warrants to the original purchaser of Endless Pools Fitness System Swim Machine to be free from defects in materials and workmanship for two years. Watkins obligations under this warranty shall be limited to the repair or exchange (at our option) of any part or parts which may thus prove defective under normal use within two year from the date of purchase by the original purchaser, and which our examination shall disclose to our satisfaction to be thus defective.

This warranty is expressly in lieu of all other warranties expressed or implied including the warranties of merchantability and fitness for use and of all other obligations or liabilities for all damages direct or consequential to person, property, or business whether or not occasioned by our negligence, and we neither assume for us any other liability in connection with the sale of this Swim Machine.

This warranty shall not apply to this Swim Machine or any part thereof, which has been subject to accident, negligence, freezing, improper installation, alteration, abuse, or misuse.
